

## **INTEGRATED POLICY FOR QUALITY**

- **it undertakes, through a risk-based approach, to continuously improve the effectiveness of the Quality Management System according to the UNI EN ISO 9001 standard**
- **uses a Quality Management System proper to the requirements of EN 80079-34, for the safe management of its EX products intended for use in potentially explosive atmospheres**
- **carries out every welding process, relevant to structural products, according to the UNI EN ISO 3834-2 standard**
- **applies a factory production control system certified in compliance with the requirements of the UNI EN 1090 standard, as far as structural product and processes are concerned**

AGI EMEA also undertakes to consolidate the organization in charge of defining and reviewing the objectives for quality.

General targets to be achieved through the Quality System are:

- design and build systems, structures and machines that guarantee safety, functionality and reliability
- represent a leading brand in the sector of storage, conservation, carriage and processing of cereals
- focus attention on customer and third parties satisfaction, developing an ever greater ability to read market needs and requirements;
- focus on internal and external (outsourcing) organizational improvements
- periodically monitor the effectiveness of the management system, to verify its adequacy over time with respect to targets stated for its customers, to the needs of the third parties and to changes in the relevant factors, as well as to prevent any situations of non-compliance with the system requirements
- improve communication and inter-relationship between the various company processes, in order to raise awareness of all human resources towards common objectives in terms both of quality for own products and processes, and of personal safety
- comply with customer requirements in response to requests relating to storage or transport solutions for products in contact with food for human consumption, falling under Reg. 1935-2004 MOCA

To achieve such targets the Company undertakes to optimize its business processes, in order to ensure a management system that respects criteria of efficiency, effectiveness and economy, guaranteeing high standards of safety in the workplace and environmental protection.

Both policy and targets are systematically verified, in order to assess their adequacy and the degree of application / achievement.
